#### About the Company:

MQ TV will launch at the end of 1Q 2025 and mQ Films will launch during 2Q 2025.

This is an opportunity to take on a high-level role in a fast growing and pre-IPO company that involves closely working with the senior management team, department heads and other stakeholders as our streaming services mQ Films and mQ TV disrupt the \$500BN global streaming industry.

#### <u>Overview</u>

The Head of mQ Films role is responsible for the identification and creative development of mQ Films original programming. This role is also a senior vice president executive position. Working closely with filmmakers, producers, and film festivals, the Head of mQ Films will bring in new projects that align to the mQ Films brand and helps internationally from development through production and strategizing around any film festivals and awards (where applicable). This position reports directly to the CEO, MolQ Entertainment and will be expected to have deep and broad relationships within the independent film community both in fiction, non-fiction, documentary arenas and original production of film content.

#### **Responsibilities**

• Department Head of mQ Studios and will develop and oversee the slate of original programming that aligns to the creative vision of mQ Films.

- Oversee the development and production of original programming including scripted and unscripted films and series. A background in both scripted and unscripted is preferred, but scripted is a requirement.
- Development and maintain industry relationships with agents, producers and talent
- Bring in potential projects for development or acquisitions through pitches or submissions from outside companies, talent agencies, studios and independent production companies
- Identify IP for mQ Film Studios to option and develop
- Review scripts, casting, budgets, creative documents, and other materials for development and production.
- Supervise editorial over outside production companies on multiple series/films simultaneously to ensure timely and on-budget delivery of programming
- Manage the Vice President Original Programming, Vice President Film Acquisitions and Director of Productions positions
- Knowledge of all aspects of contemporary production and post-production capabilities.
- Oversee mQ Films budgets including original content, film acquisition and production budgets and schedules
- Partner with other departments on launches, press, marketing and general programming needs
- International content experience is valued
- Work closely with MolQ Entertainment's CEO regarding strategy, timelines, and direction of original productions
